The Bin Ident System is coming! New digital recognition system for your residual and organic waste bins

Dear Citizens of Oldenburg,

The residual and organic waste bins in our city will finally get new fee labels in the second half of the year. These will be delivered at different times (staggered by postcode districts) over the next few months. The labels are now digitally readable instead of the previous fee stamps and help to identify the waste bins. This procedure is called the Bin Identification System, or Container Ident System for short. It should significantly simplify the processes associated with the waste bins for you and us. This will do away with the tiresome annual stickers, which will reduce the workload for everyone involved. But what is even more important: The new system has a higher level of fairness than the current one.

We need your help!

We need your active support during the introduction. Because you have to label your residual and organic waste bins once on both sides. Each label contains a barcode and a transponder. Our waste collection vehicles are equipped with a reader so that the emptying processes are digitally recorded and unregistered bins will no longer be emptied in future.

As a property owner, as an authorised property manager or authorised person, you will receive two labels enclosed with this letter for each registered residual and organic waste bin. Please stick the labels on the waste bins according to the enclosed instructions.

Another advantage of the new system is that the previous return of brand remnants is no longer necessary. Please note that in future the label number (to be found under the barcode) must be given for registrations and deregistrations.

You have an organic summer bin and use a second bin for it? Then please note that your current sticker is still valid this season, and you will not receive a separate ident sticker for this second bin. If you would like to use a second bin in 2024, please get in touch using the email address above in the header.

As in the past, bins without a current sticker will no longer be emptied after the introductory period, so you should return the bins no later than <u>within four</u> <u>weeks</u> after receipt of this letter at the latest.

Please note that your blue bin for paper and your yellow bin (if available) for packaging waste are not affected by this because they are not emptied by the AWB.
